**ROBERTS: A JUDICIAL POWER GRAB WITHOUT PRECEDENT**

Roberts has **once again bypassed constitutional norms**, acting as a political enforcer rather than a neutral jurist.

- **He reversed his own stay without issuing an official decision.**
- **He provided no legal justification for his actions.**
- **He enabled a judge with no jurisdiction to order a massive taxpayer payout.**

**The Supreme Court itself has rebuked Roberts and Ali's actions as a dangerous violation of judicial authority.**

With a confidence that could rival the boldest figures in American history, Chief Justice John Roberts, with remarkable audacity, overruled Trump's decision to stop the payment of \$2 billion in taxpayer money to political parties that oppose his policies. Roberts used manipulative administrative sleight of hand to rubber-stamp Judge Amir Hatem Mahdy Ali's order, which required payments unrelated to

“invoices or drawn-down requests” and has “thrown what should be an orderly review by the government into chaos.”

Roberts initially entered an administrative stay and then reversed himself. Three Supreme Court justices emphatically agreed that Ali lacked authority to compel Trump to issue a rushed \$2 billion taxpayer-funded payout. They stated that they were stunned by Roberts’ and the appeals court’s failures to protect the Constitution from abuse and deliberate violations of well-established case law by Ali. They pointedly wrote that Roberts “blithely discards sovereign dignity” and found that Ali’s order was “an act of judicial hubris” that “imposes a \$2 billion penalty on American taxpayers.”

If President Trump has given the People of the United States one great, undeniable gift, it is exposing the monolithic corruption that exists in U.S. courts. Judicial fraud and corruption is not new.

From the beginning of our nation, Americans have had to fight to protect their liberty and property from corrupt judges. The Federalist Party, under John Adams, a Federalist lawyer, executed the greatest judicial fraud in American history—the Midnight Judges scheme. Adams executed the scheme with the help of another Federalist lawyer, John Marshall, who was both Adams’ Secretary of State and Chief Justice.

Marshall, sitting as Chief Justice, ruled on the very scheme he helped execute in *Marbury v. Madison* (1803). Thomas Jefferson crushed the Federalist scheme in the Revolution of 1800, dismantled Adams’ entire judicial structure, and removed corrupt Federalist judges from power. Jefferson ignored Marshall’s *Marbury* decision as a meaningless attempt to dictate judicial supremacy. Jefferson defeated the Federalists so decisively that the party was left for dead—and did die shortly thereafter.

Roberts used his Annual Report to threaten President Trump by invoking *Marbury*. With no hesitation, Roberts cited a Midnight Judge’s claim of judicial supremacy over the Constitution and the other branches of government as his authority. Now, Roberts has acted on his warning, using Ali—a 21st Century Midnight Judge.

Ali is a Biden-appointed judge who received his commission on November 22, 2024. He became the first Muslim and Arab American federal judge to serve in D.C. He was confirmed in a 50-49 vote to join the nation’s second most powerful court. During his confirmation hearing, Ali was questioned about his association with advocates of defunding the police.

I am writing to you as the Chairman of the Republican Party of Florida’s St. Johns Presidential Committee—not because the RPOF, Republican National Committee (RNC), or Governor Ron DeSantis supported me, but because the RNC, RPOF, and DeSantis tried to cancel me—and they lost.
