


### **THREE MAIN PLANKS**

#### **REGULATED & TESTED ADULT-USE CANNABIS MARKET** 1)

Our laws have failed and Albany is paralyzed by entrenched status quo. Our laws have not prevented young people from using marijuana. Too many New Yorkers end up with criminal records for possessing small amounts of the drug. Arresting and prosecuting these offenses is expensive. It traps too many of us in the criminal justice system for minor, nonviolent offenses. At the same time, the proceeds from the illegal drug trade support organized crime, corruption and greater threats to public safety, like human trafficking and hard drugs.


To ensure that we keep marijuana out of the hands of children, and the profits out of the hands of criminals, we must legalize, regulate, and restrict access to marijuana in New York State. We must remove cannabis consumption and incidental possession from our laws, and create new, stronger laws to punish more severely those who provide it to minors, operate a motor vehicle while under its influence, or sell it outside of our new regulatory framework.






#### **ROBUST MEDICAL MARIJUANA PROGRAM** 2)

New Yorkers must have access to medical marijuana without restriction on method of ingestion or qualifying conditions. For all cases where a physician may prescribe a prescription drug for a medical condition, medical marijuana must be an allowable treatment.



#### 3) INDUSTRIAL HEMP AS A COMMODITY CROP

New York farmers must be allowed to grow and process industrial hemp subject only to restrictions applicable to any other commodity crop in New York State.

We will work to approve the call for a New York State Constitutional Convention on Nov 7, 2017. At that convention we will design frameworks for:

- 1) a strictly regulated & tested cannabis sales & distribution market, with appropriate taxes & license fees,
- 2) a robust medical marijuana program that gives broad access to New Yorkers in need, and
- 3) an industrial hemp program that restores to New York farmers the access they had before prohibition, and we will put these frameworks *before New York voters to decide* on November 5, 2019.
