




# Laboratory Animal Care Audit

Findings from 2023 USDA inspections of laboratories that use animals



The inaugural Laboratory Animal Care Audit details conditions found at laboratories that used animals in the United States in 2023. The National Anti-Vivisection Society has published this report to promote greater awareness of the experiences and living conditions that lab animals are subject to and to encourage ongoing dialogue about the use of animals in research, testing, and teaching.



# **Report Highlights**

- This inaugural report details conditions found at 90 laboratories that used animals in 34 states in 2023.
- California has the highest number of laboratories detailed in this report (12). Other heavily represented states include Texas (8), Massachusetts (7), and New York (6).
- Charles River Laboratories reported housing and using 46,694 animals for research and testing purposes in 2023, more than any other facility in this report.
- Thirteen of the 90 facilities detailed in this report have been issued a fine for violations of the Animal Welfare Act (AWA) identified in 2023.
- Common issues found at regulated laboratories: inadequate personnel training, mishandling of animals resulting in animal injury and death, poor veterinary care, insufficient housing for various species, poor sanitation and waste management, conducting unapproved procedures on animals.

All of the information in this audit is publicly available on the United States Department of Agriculture's (USDA) website. This audit references 2023 annual reports and 2023 USDA inspection reports.

# 2023 Annual Reports:

Laboratories that use animals and are registered with the USDA must submit annual reports with a count of the number of animals housed and used that fiscal year for research, testing, and teaching. Laboratories report the number of dogs, cats, Guinea pigs, hamsters, rabbits, monkeys, sheep, and pigs. All other species that are required to be counted fall in the "Other animals" category.

The animals counted are also grouped into the following USDA-defined pain categories:

Pain Category B	Animals bred, conditioned, or held for use in experiments but are not yet part of any experimental procedures. Examples include breeding animals, euthanizing animals on holding protocols, or observing animals in their enclosures without manipulation.
Pain Category C	Animals are used in experiments that do not involve pain and/or distress. Includes activities such as positive reward training, food restriction, and manipulative procedures like weighing and injections.
Pain Category D	Animals are used in experiments that involve pain and/or distress, but pain relief is provided. Examples include surgical procedures with appropriate anesthetics and analgesics, tumor induction with pain alleviation, and euthanasia under anesthesia.
Pain Category E	Animals are used in experiments that involve pain and/or distress and are not provided pain relief. This includes experiments causing paralysis or immobilization, food and/or water restriction leading to significant weight loss, exposure to noxious stimuli from which the animal cannot escape, long-term restraint, and toxicological or infectious disease experiments where pain relief is not given.

# 2023 USDA Inspection Reports:

Inspections are part of the USDA's mandate to enforce the Animal Welfare Act (AWA), which sets forth the minimum standards of care and treatment for animals used for research, exhibition, transport, breeding, and by dealers. The issues documented in this audit are violations of the AWA that USDA inspectors noted on 2023 inspection reports while inspecting laboratories that house and use animals that are covered by the Animal Welfare Act.



# Additional notes:

This audit does not include any information on laboratories that use animals who are not regulated by the USDA. The AWA excludes the most-used laboratory animals – mice of the genus Mus and rats of the genus Rattus – as well as birds, invertebrates, fish, and cold-blooded species from the definition of "animal" under the law. Laboratories that use only these excluded species are not registered with, nor inspected by, the USDA, and are not subject to AWA regulations on animal care. Also, laboratories that use these excluded animals in addition to animals covered by the AWA do not include them in the annual reports they submit.

It is also important to note that the kind of research being done on animals, and whether that research is ethical or valid, does not fall within the purview of USDA inspections. Therefore, this audit does not speak to these important aspects of research. This audit focuses exclusively on the findings of USDA inspectors at registered animal-use laboratories in 2023.

This audit is not meant to be an all-inclusive detailing of the issues found at laboratories that used animals in 2023. As the goal of this audit is to illuminate the living conditions and basic treatment of animals in laboratories, we did not include information on administrative issues that did not directly impact animal health or welfare, of which there were dozens. While we acknowledge that deficiencies in administrative rigor can ultimately end up harming animals, for brevity's sake such deficiencies are not documented here.

#### Issues documented on an August 2023 USDA inspection report:

- A teaching assistant was euthanizing rabbits by cardiac injection of a euthanasia drug. An investigation found that the teaching assistant was not properly trained and was unable to successfully accomplish the procedure.
- Two rooms housing dogs had waste drainage gutters that contained an excessive amount of buildup, with brown discoloration visible on the flooring.
- Primary enclosures for dogs and cats were not being appropriately sanitized.

- Several outdoor pastures housing horses did not provide sufficient shelter from the elements.
- Multiple short-tailed opossums did not have access to uncontaminated food.
- Outdoor enclosures housing eight alpacas, one llama, and 14 sheep had an overgrowth of large weeds and several large ant mounds. It was noted that the conditions make it difficult to perform husbandry tasks, limit usable space for the animals, and act as breeding grounds for pests.

To date, Auburn University has not received any fines or penalties for the issues described.

#### Issues documented on a January 2023 USDA inspection report:

- Problems related to a 10-year-old yellow Labrador named Spring:
  - Limping and reluctant to bear weight on a hind limb.
  - She had a 0.5-inch diameter firm round mammary mass and several pink skin sutures with no recent surgery records to explain the sutures.
  - Spring was not being given all the necessary doses of her prescribed medications.
- Problems related to an 8-year-old female Weimaraner named Star:
  - Star had a 2-inch-long oval shaped firm mass in the middle of her back. The lump had not been documented in medical records or communicated to the attending veterinarian.
  - Star had been prescribed an antibiotic and an antiparasitic that had not been given on the correct schedule, and some doses were missing.
- A 12-year-old male Golden Retriever named Thor and a 10-year-old black Labrador named Blackie had been prescribed medications but were missing doses, according to medical records.

- Inspectors noted a 2-year-old Beagle named Ranger had "ribs and backbone...clearly visible" and "very little fat overlying the bones." Ranger was not identified as excessively thin by the facility, and he had last been evaluated by the vet in May 2022.
- Two dogs, a 5-year-old female Harrier named Penny and a 10-year-old male yellow Labrador named Eagles, had severe dental disease that had not been identified by the facility.
- Multiple issues with incomplete medical records:
  - A 10-year-old female black Labrador named Magic was euthanized in early 2023, but her medical records did not contain any entries after May 2022. Staff stated that Magic was euthanized because she was not doing well, but medical records didn't include a reason for euthanasia.
  - An 8-year-old male Weimaraner named Klondyke was taken to the vet for evaluation of his thin body condition. Nothing was noted regarding the results of the vet visit.

#### Issues documented on a February 2023 USDA inspection report:

- A 12-year-old yellow Labrador named Blue had difficulty standing, walking, and moving around her kennel. Despite being taken to the vet earlier in the year, medical records contained no mention of hind limb issues, results of examination, or plan for treatment.
- Eight fox terriers were found without drinking water available. During inspection guillotine doors were opened in the kennels to give the dogs access to water, and the eight dogs "began drinking from their water buckets eagerly. The dogs drank continuously for one minute, with some drinking for 1.5 minutes."
- A yellow Labrador named Party Girl had severe dental disease and mammary masses that had not been identified by the facility.



#### Issues documented on an April 2023 USDA inspection report:

- Three dogs had medical issues that had not been documented in medical records:
  - Three dogs, an 11-year-old yellow Labrador named Showboat, a 12-year-old Golden Retriever named Thor, and a 9-year-old yellow Labrador named Sunny all had severe dental disease.
- Three dogs were diagnosed with low thyroid blood test levels and were started on thyroid medication. All three dogs were past due for follow-up thyroid testing to ensure that the correct dosage of the medication was being administered.

#### Issues documented on a July 2023 USDA inspection report:

- Eleven-year-old yellow Labrador named Bow was severely overweight and had difficulty rising from the concrete floor. Her front limbs kept sliding out from under her. Previous exam results show her being placed on thyroid medicine but no evaluation for her weight or difficulty standing.
- Shadow, a 10-year-old black Labrador, was seen for heart issues on May 2, 2023. The vet requested a re-check in two-six weeks. About 10 weeks after the initial exam, no re-check had been done.
- Three dogs were diagnosed with low thyroid blood test levels and given medication, but none of them had received necessary follow-up testing by time of inspection.

# Issues documented on an October 2023 USDA inspection report:

- A Norwegian Elkhound had been spayed nearly a week before the inspection. At time of inspection the dog did not have an Elizabethan collar and was seen frequently licking and scratching the incision site, which was bright pink with darker pink around the edges. The attending vet had not been notified about the inflamed area.
- The facility knowingly obtained a random source dog in violation of the Animal Welfare Act.

- Multiple outdoor dog exercise pens had fencing in disrepair, including rust, jagged edges, and holes at the bottom of multiple chain-link and wooden fences.
- Peeling was paint found throughout the facility, exposing areas that could not be effectively sanitized.

- Twelve-year-old yellow Labrador named Snowflake did not receive daily medication as prescribed.
- Fencing issues noted in the April inspection report were only partially repaired.
- In approximately 20% of dog enclosures, dog kibble was seen on the floor. It was noted that food receptacles must be used so dog food does not become contaminated by feces and pests.
- Issues with medical records make it difficult to ensure that dogs receive complete medical care.
- A Norwegian Elkhound named Inga and her five puppies were housed in an area containing a heat lamp. The electrical cord was easily accessible by the adult dog and would be easily accessible by the puppies once they were strong enough to leave the whelping box.
- Dog cages were observed with cracks in concrete and unsealed areas that may harbor organic material, parasites, or germs that can be harmful to dogs.
- Issues with medical records make it difficult to ensure that dogs receive complete medical care.



To address the 2023 issues found at the facility, Blue Ridge Kennel was ordered to pay a fine of \$48,000, with an additional \$32,000 if they continue to violate the law over a four-year probation period.

#### Issues documented on a July 2023 USDA inspection report:

- Two goats had inflamed/infected nodules under the skin where they received research related injections. The infections were not brought to the attention of the vet and had not been treated.
- A goat broke her horn near the base and "did not feel well for days afterward." The vet was not notified, and the goat died without treatment 12 days later.
- Facial hair loss on a New Zealand white rabbit had not been reported to a vet.
- Six Savannah goats were banded for castration without anesthetics or pain control medication.
- The inspector witnessed a live, wild raccoon in a barn housing rabbits, several dirty rabbit food receptacles, and improper sanitation of rabbit enclosures.
- Additional issues noted: damage to enclosures that could cause harm to llamas; dirty water receptacles in goat enclosures; and accumulation of dirt, fecal material, debris, hair, rat feces, and an extreme number of large cobwebs in goat enclosures.

#### Issues documented on an October 2023 USDA inspection report:

- The rabbit who had hair loss in July still had not been treated. Two additional rabbits exhibited hair loss. At the end of July, the attending veterinarian recommended that all rabbits be given a monthly medication to treat hair loss. No such medication had been given to any rabbits.
- Inspector noted that "repairs continue to need to be made" to address issues found in July.

In October 2023, Southern Biotechnology Associates Inc. received an Official Warning Notice of Alleged Violation for the July violations. No fines or penalties have been issued to date.

#### Issues documented on a May 2023 USDA inspection report:

- A lab member used isoflurane to sedate six animals for an injection because they were not comfortable injecting the animals while awake. The experimental protocol did not approve isoflurane use, and the isoflurane was expired.
- A cage housing three shrews needed cleaning. Excreta, both fresh and up to four weeks old, was built up on perches, shelves, and the floor of the cage, with some excreta growing fuzzy white mold. The feet of multiple shrews were contaminated with excreta.

To date, the University of Alabama at Birmingham has not received fines or penalties for the issues described.

#### Issue documented on an August 2023 inspection report:

• A student witnessed another student slap a 1-year-old Staffordshire terrier named Harold across the head during handling activities.



To date, Western Maricopa Education Center has not received fines or penalties for the issue described.

In FY 2023, 784 laboratories reported using 844,915 animals covered by the Animal Welfare Act.

# Facility's 2023 Annual Report records zero animals at the facility. Issue documented on a March 2023 USDA inspection report:

• Three rabbits suffered spinal fractures while being handled by staff, which resulted in the veterinarian killing all three rabbits.



In May 2023, Amphastar received an Official Warning Notice of Alleged Violation for mishandling of animals. No fines or penalties have been issued to date.

#### Issue documented on a March 2023 USDA inspection report:

• Numerous examples were found where body temperature was not correctly recorded during anesthetic procedures on dogs and monkeys. Temperature was recorded as "NA."



To date, BTS Research has not received fines or penalties for the issue described.

#### Issues documented on an August 2023 USDA inspection report:

- Review of documents revealed that one researcher deviated from approved experimental procedures on numerous occasions:
  - The researcher implanted a pacemaker in a pig without proper sterilization of the device. The device was immersed in disinfectant for 20 minutes before being implanted. Protocol called for the device to soak a minimum of 10 hours in a chemical sterilant, rinsed with sterile saline, and then soaked for at least 10 hours in sterile saline.
  - A procedure involving a large blood vessel in the thigh was performed on a pig without prior veterinary consultation.
  - A pig was given an injection of stem cells, but the procedure was not in an approved protocol.
  - The researcher scheduled a pig to undergo surgery for telemetry implantation as a stand-alone procedure. The protocol called for more invasive procedures, so the pig underwent a less invasive procedure than was approved.
  - A non-survival surgery was performed without approval on a pig that involved cutting the pig between its ribs to access organs in the chest or thorax.



To date, Cedars-Sinai Medical Center has not received any fines or penalties for the issues described.

#### Issue documented on a July 2023 USDA inspection report:

• Multiple monkeys were injured during acclimation training to poling, chairing, and other restraints. Injuries on the monkeys included abrasions on various parts of the body, a neck lesion with swelling, hand and foot injuries, and "reopening of neck wounds."

#### Issue documented on a November 2023 USDA inspection report:

• Veterinarians needed permission from study directors before administering treatment. This played out when a veterinarian recommended euthanasia for an animal due to declining health and had to wait for the study director to approve the euthanasia. It was noted that if vets cannot independently make decisions, it could lead to unnecessary pain and suffering for animals.

In September 2023, Joinn Laboratories received an Official Warning Notice of Alleged Violation for mishandling of animals. No fines or penalties have been issued to date.

#### Issue documented on an August 2023 USDA inspection report:

• A pig was anesthetized for about 30 minutes when the attending vet stepped away and left a technician, who was not sufficiently trained in animal anesthesia, to oversee it. After five minutes the vet returned and attempted to revive the pig without success. The attending vet stated, "pigs are sensitive to anesthesia, and it is not uncommon for incidents like this to occur."

To date, the Lundquist Institute has not received any fines or penalties for the issue described.

Laboratories are not required to provide data or information on the number of mice and rats they use. Estimates put the number of mice and rats used in research in the United States between 10 million and 111 million animals per year.

#### Issue documented on a June 2023 USDA inspection report:

• A Siberian hamster escaped from its cage, got out of the housing room, and got caught in a hallway pest control trap. The animal was found and assessed; the decision was made to kill it.



In August 2023, Stanford received an Official Warning Notice of Alleged Violation for mishandling of animals. No fines or other penalties have been issued to date.

#### Issue documented on a March 2023 USDA inspection report:

• Bats had been moved from their main cage into a temporary cage for cleaning. Once cleaning was complete the employee opened the door of the temporary cage to let the bats fly back into their main cage. The temporary cage was then sent to be washed. Two bats were found dead six days later in the temporary cage. Cause of death was "exposure to 180-degree water" in cage wash.

#### Issue documented on a September 2023 USDA inspection report:

• A vole was found dead with cause of death being a wound rupture along the surgical incision.

In May 2023, UC-Berkeley received an Official Warning Notice of Alleged Violation for mishandling of animals. No fines or other penalties have been issued to date.



#### Issue documented on a May 2023 USDA inspection report:

• Four animals were used in a teaching protocol that had not been approved.

#### Issues documented on an October 2023 USDA inspection report:

- A 10-year-old overweight macaque monkey was moved from an indoor cage to outdoor group housing. About three months later the monkey showed signs of lethargy, diarrhea, and weight loss. At that time, he weighed 8.17kg, representing significant weight loss over the three-month period that was never noted by staff. The monkey was killed by staff one day after the significant weight loss was noticed.
- Two rhesus macaque monkeys were transported from one building to another for an experiment. Upon arrival at the receiving building, one monkey was taken into the building while the other, a geriatric female, was left in the van. During the second check of the monkey in the van, she was found unresponsive. She never regained consciousness and was ultimately killed. Necropsy indicated the death was likely heat related.



#### Issue documented on a December 2023 USDA inspection report:

• A female sheep went into labor and gave birth to four lambs in her stall. A small, enclosed area was set up using an existing pen at the rear of the stall. One of the lambs ultimately caught its head/neck between a vertical metal bar and the wall of the smaller pen and was found unresponsive and ultimately died.

To date, UC-Davis has not received any fines or penalties for the issues described.

#### Issue documented on a December 2023 USDA inspection report:

• During a cardiac experiment involving a pig, heparin was supposed to be administered to prevent blood clotting, but it wasn't. The pig went into cardiac arrest and was killed without recovering from anesthesia.

To date, UC-Irvine has not received any fines or penalties for the issues described.

#### Issues documented on a May 2023 USDA inspection report:

- Medical record numbers were mixed up for two rabbits. One rabbit went through surgery but did not receive pain relief medication afterward. Another rabbit, who was not subject to surgery, received pain medication.
- A last-minute switch in the type of experiment performed on a rabbit resulted in the animal not receiving pre-procedure antibiotics.
- Two Guinea pigs were placed in a holding cage with insufficient air flow, resulting in the death of the animals due to asphyxiation.

#### Issue documented on a September 2023 USDA inspection report:

• Upon encountering unexpected issues during surgery, a researcher aborted the approved surgical procedure for three pigs. The animals recovered, and then two underwent further procedures. The mix up resulted in one pig not receiving post-operative pain relief, and one pig being fasted for approximately 24 hours, which exceeded the approved fasting time of 12 hours.



In July 2023, UC-Los Angeles received an Official Warning Notice of Alleged Violation for issues documented in May. No fines or penalties have been issued to date.

#### Issue documented on an August 2023 USDA inspection report:

• A researcher failed to notify the vet of unanticipated mortalities of eight of 11 voles. Three voles died in July 2022 and five were found dead in August and early September of 2022. After being informed of the ninth vole death, the vet performed a necropsy, which showed the animal had a bacterial lung infection. The lack of timely communication between the researcher and the vet prevented the vet from minimizing the number of vole deaths.

In September 2023, UC-Riverside received an Official Warning Notice of Alleged Violation for issues documented in August. No fines or penalties have been issued to date.

In FY 2023, 46,848 dogs were reportedly housed and used for experiments. Of those, 450 dogs were subjected to experiments that caused pain or distress, but they were not given any pain relief.

- One pocket mouse was mistakenly placed in the wrong enclosure, resulting in death.
- One pocket mouse escaped through a camera port in its cage and was never caught.




In July 2023, the Zoological Society of San Diego received an Official Warning Notice of Alleged Violation for issues found in April. No fines or penalties have been issued to date.

- A 2-year-old rhesus macaque monkey was found dead in an outdoor cage. She was found with her head inside a gap in the wall dividing two cages.

#### Issues documented on a August 2023 USDA inspection report:

- Thirty-two rabbits were killed after they were given mis-dosed eye drops. After being given the drops, the rabbits showed eye irritation. It was discovered that the eyedrops' pH was between 5.09-5.56 when it should have been between 6-7.4. The study director determined that additional data from the rabbits would be unusable, so the decision was made to kill them.

- Rabbit #19 escaped its cage and rabbit #15 was found stuck halfway through the cage door bars. On initial observation rabbit #15 had bruising and appeared dazed. A later check found no abnormalities.





In November 2023, MRIGlobal received one Official Warning Notice of Alleged Violation for the rabbits and macaque monkeys who were killed after staff errors. No fines or penalties have been issued to date.





#### Issues documented on a January 2023 USDA inspection report:

- Four chinchillas were not removed from a study according to experimental protocol after experiencing more than 20% weight loss. One animal was killed after losing 27.9% body weight, one was killed after losing 30.7% body weight, one was killed after losing 25.5% body weight, and one died after losing 25.1% body weight. The experimental protocol also stated that animals would be in the study for 22 weeks. Some animals remained in the study for 21 months.
- Multiple rhesus macaque monkeys experienced severe low blood sugar and prolonged anesthesia recovery times.
  - One macaque monkey (DA9J) died after an experiment where he received intravenous insulin. He did not receive medical intervention for more than seven hours after the experiment, despite being barely responsive. He did not fully wake up from the procedure, so the decision was made to kill him.
  - Eleven other rhesus macaques underwent the same procedure and received no monitoring of their blood glucose or medical interventions from low blood sugar despite having blood glucose levels that were so low they were undetectable. These animals all took an excessive amount of time to recover from anesthesia, some more than five hours. Prior documented recovery times for these same animals ranged from 45 minutes to one hour.

- The procedure was performed again on six of the same animals and records again showed multiple animals had blood glucose levels so low that they were not detectable for prolonged lengths of time. This led to multiple animals suffering from incredibly low blood sugar without medical intervention.
- Two rhesus macaques (HHA and AB67) were used in an experiment despite being older than the maximum age of 23 years described in the experimental protocol.
- Five animals (species was not identified) were used in an experiment despite being below the minimum weight required.
- Two monkeys (HHA and 35R) were given more than the approved amount of a sweetened beverage as part of an experiment, and the duration of time that the monkeys received the sweetened beverage was extended without approval from 3-6 months to 7.5 months.
- Six macaque monkeys underwent procedures, including sugar injections and blood draws, that were not pre-approved.

VIRGINIA

#### Issues documented on a May 2023 USDA inspection report:

- Multiple deviations from a pre-approved pregnancy experiment were documented. Deviation from pre-approved experiments has been noted at this facility in the past:
  - Protocol called for female Baboons to undergo blood sampling under ketamine sedation at 2-4 day intervals. Records showed that two Baboons,17-year-old "Alissa" and 16-year-old "Jemma", underwent daily blood draws during various time periods.
  - Protocol called for monthly or weekly weigh-ins of Baboons. Records indicated that five female Baboons only had weights documented during their semi-annual physical and tuberculosis test or during surgical procedures.
- The protocol described an anticipated adverse event, seizures, in 10% of animals receiving a study drug from days 100-170 gestation. Treatment steps in the event of a seizure were documented in the protocol. Sixteen-year-old baboon "Jemma" was found unresponsive by a technician and no records indicate that treatment was provided per the protocol. By the time the attending veterinarian arrived the Baboon was eating and responsive.



To date, Eastern Virginia Medical School has not received any fines or penalties for the issues described.

## Issues documented on a January 2023 USDA inspection report:

- Facility personnel did not place an IV catheter in a baby cow within two days of administering an infectious agent, per protocol. The calf became ill six days after being given the infectious agent and died shortly thereafter.
- A staff member injured a gerbil during a blood draw procedure by restraining it too tightly. The gerbil was placed in a restraint device and the staff member used additional manual restraint, which was unnecessary. The gerbil became nonresponsive in the restraint device and was ultimately killed.
- An experiment that included exposing piglets to low oxygen conditions stated that weight would be monitored, and blood draws would be performed. The lead researcher confirmed that blood draws and body weight were not collected at the approved intervals. Also, the piglets were housed in oxygen deprived chambers that had not been pre-approved.
- Some dogs received unnecessary duplicate vaccinations despite documentation that they had recently received the same injections.

## Issue documented on a April 2023 USDA inspection report:

• Many feces were seen along the back wall of the horse hay storage building, potentially contaminating the food. The feces looked to be from a wild mammal. The facility occasionally traps wild animals, but it was noted that "due to the quantity of feces observed, the current pest control program is ineffective."

#### Issue documented on a July 2023 USDA inspection report:

• Inadequate staff training for health monitoring led to three gerbils dying and two gerbils becoming ill and requiring care.

In March 2024, Virginia Polytechnic Institute & State University was fined \$18,950 in connection with the piglet experiments, calf death, and inadequate staff training in the gerbil deaths. The fine also addressed problems documented by the USDA in 2021 and 2022.

#### Issue documented on a March 2023 USDA inspection report:

• A facility housing seven pig-tailed macaque monkeys reached a temperature exceeding 85°F for more than four consecutive hours. Environmental monitoring records show the temperature to be between 85°F and 88.2°F between July 14 and July 18, 2022, for five time periods lasting between 4-9.5 consecutive hours.

## Issues documented on a September 2023 USDA inspection report:

- While under anesthesia, a male rhesus macaque monkey experienced poor oxygenation and a rapid, irregular heartbeat. A technician brought in a portable anesthesia machine, and when the monkey was attached to the machine it stopped breathing and went into cardiac arrest. It was found that the portable machine did not work properly.
- A researcher-in-training damaged the cerebral tissue of a macaque monkey while implanting a recording device. The animal exhibited noticeable neurological impairment within minutes and the procedure was terminated and treatment was initiated.
- Eighteen ground squirrels had a temperature sensor implanted in their abdomens, and six of the 18 squirrels developed complications.
- A pigtail macaque monkey underwent a second surgical procedure to replace a telemetry implant when only one replacement surgery was approved.
- A daily ration of water was not administered to a rhesus macaque monkey.

To date, the University of Washington has not received any fines or penalties for the issues described.

#### Issues documented on a March 2023 USDA inspection report:

- A macaque monkey was identified as lethargic and dehydrated. The veterinarian was notified, but the macaque had to be killed. It was determined that prior incidences of the monkey having loose and watery feces were not communicated to the attending veterinarian per protocol.
- The inspector noted a macaque monkey with a tight collar. Abrasions were treated.
