In the event of a dispute regarding any Submission, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being an authorized account holder.

6. Winner Determination: After the conclusion of each Entry Period, a panel of qualified judges determined by Sponsor in its sole discretion will select a potential winner from among all eligible Submissions received, based on an application of the following criteria ("Judging Criteria"):

The creativeness in your work and the attractiveness of your travel story (70%)

7.Winner Requirements: Potential winners will be notified by email or phone on or around the dates set forth above.
